If I have any problems that cannot be resolved with the school, I may write the Private Occupational Schools Division of the Department of Higher Education of the State of Colorado, 1380 Lawrence St., Suite 1200, Denver, Colorado 80204-2059. There is a two-year limitation for the Division to be able to take action on a complaint.

This agreement, in addition to the school catalog, my program start date, and the Money-Back Guarantee included with this agreement shall be considered a part of this contract for my protection. If you do not accept my agreement, you will refund all my money promptly.

I have read the truth in lending disclosures at the left and wish to enroll. I understand you will send my first lesson materials by return mail.

It is my responsibility to verify whether or not the clock hours earned from the institution will transfer to other institutions or meet specific state, municipal, and/or employee training requirements.

I have enclosed my check or money order (or made arrangements) for the amount of the down payment and agree to make monthly payments as shown in the column at the left.

My first monthly payment will be due 30 days or more after my enrollment agreement is accepted. Thereafter, each payment will be due on the same day of the month as my first monthly payment.

Students may withdraw from U.S. Career Institute® at any time by notifying us of their intent to cancel. The tuition students owe upon withdrawal is determined by how many of the assignments they have completed, deducting all payments made. Upon cancellation, the amount due to the school or the amount refunded to the student is calculated according to the following schedule:

1. If the student cancels within seven (7) calendar days after receiving the materials, and has not submitted any assignments, the student is entitled to a full refund, upon the school's receipt of the unused materials.
2. If the student cancels after seven (7) calendar days and has not submitted any assignments, the school is entitled to a non-refundable registration charge of 20% of the total tuition, not to exceed \$150.
3. If the student cancels after submitting an assignment, the school is entitled to the above non-refundable registration charge plus a charge calculated according to the following schedule:
  - a. If the student completes up to 10 percent of the assignments, the school is entitled to 10 percent of the refundable tuition.
  - b. If the student completes between 11 and 25 percent of the assignments, the school is entitled to 25 percent of the refundable tuition.
  - c. If the student completes between 26 and 50 percent of the assignments, the school is entitled to 50 percent of the refundable tuition.
  - d. If the student completes between 51 and 75 percent of the assignments, the school is entitled to 75 percent of the refundable tuition.
  - e. If the student completes more than 75 percent of the assignments, the school is entitled to the full tuition.
